

Christmas Promotion 2017 Terms and Conditions

1. Information on how to claim and information on the Promotion form part of these Terms and Conditions. Participating in this Promotion is deemed acceptance of the Terms and Conditions of entry. Only registrations which are submitted and comply with these conditions of entry may take part in this promotion.
2. The offer is only open to Australian residents who purchase the participating models during the Promotion Period. The directors and employees of the Promoter, its related companies, agencies, suppliers and JURA stockists (and members of all such persons' immediate families) are ineligible to participate in the Promotion. Claim forms with an address outside of Australia will be deemed invalid.
3. This Promotion cannot be accepted or used in conjunction with any other offer. It is not transferable or exchangeable by the consumer.
4. You must pay the full purchase price for the Eligible Product during the Promotion Period in order to be eligible to receive a bonus from the Promoter. The Promoter is not obliged to honour any claim where the consumer has paid only the deposit on a participating JURA product or have entered into a rental, lay-by (unless the lay-by was commenced and paid in full during the Offer Period), seconds or scratch and dent products.
5. Only one claim is permitted per Eligible Product purchased. Multiple claims are permitted provided that a separate entry is completed for each Eligible Product purchased. A limit of 3 claims per household applies.

The online form must be completed and original receipt scanned and uploaded. Entries must be received by last mail on 14th January 2018. Claims redeemed after this date will be deemed invalid and consumers will not receive their bonus.
