

EOFY Trade-In Offer 2018 Terms and Conditions

1. Information on how to claim and information on the Promotion form part of these Terms and Conditions. Participating in this Promotion is deemed acceptance of the Terms and Conditions of entry. Only registrations which are submitted and comply with these conditions of entry may take part in this promotion.
2. The offer is only open to Australian residents who purchase the participating models during the Promotion Period. The directors and employees of the Promoter, its related companies, agencies, suppliers and JURA stockists (and members of all such persons' immediate families) are ineligible to participate in the Promotion. Claim forms with an address outside of Australia will be deemed invalid.
3. This Promotion cannot be accepted or used in conjunction with any other offer. It is not transferable or exchangeable by the consumer.
4. The consumer must pay the full purchase price for the Eligible Product during the Promotion Period in order to be eligible to receive the trade in value from the Promoter. The Promoter is not obliged to honour any claim where the consumer has paid only the deposit on a participating JURA product or have entered into a rental, lay-by (unless the lay-by was commenced and paid in full during the Offer Period), seconds or scratch and dent products.
5. Only one trade in value is permitted per Eligible Product purchased. Multiple claims are permitted provided that a separate coffee machine is traded in for each Eligible Product purchased. The consumer cannot trade in multiple coffee machines to compile the trade-in value. A limit of three trade ins per household applies.
6. Subject to these Terms and Conditions, the Promotion gives consumers the opportunity to trade in their old office coffee machine and receive up to \$1,000 off a professional JURA coffee machine from the Promoter when a consumer purchases any eligible JURA coffee machine from any nationwide participating JURA authorised dealer between 1st June to the 30th June, 2018 ("The Offer Period").
7. Consumers must provide details of the original purchase receipt to claim the trade in value. Entries via phone or email must be received by 7th July 2018. Claims redeemed after this date will be deemed invalid and consumers will not receive the trade in value. Upon validation of the claim, the Promoter will arrange free installation and training within 30 business days of purchase.
8. Each JURA Professional coffee machine purchased will be eligible for the following trade in value;

The Promoter reserves the right at any time before, on and/or after the closing date of the promotion to verify the validity of claims and to disqualify any claimant who tampers with claiming process or who enters a claim that is not in accordance with these Terms and Conditions. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
10. Any costs incurred by the consumer in entering a claim or otherwise in participating in this promotion are the consumer's sole responsibility. Liability for any tax on any benefits provided to you will be your responsibility.
