

JURA In-Home Installation Offer 2020 Terms and Conditions

1. Information on how to claim and information on the Promotion form part of these Terms and Conditions. Participating in this Promotion is deemed acceptance of the Terms and Conditions of entry. Only registrations which are submitted and comply with these conditions of entry may take part in this promotion.
2. The offer is only open to Australian residents who purchase the participating models during the Promotion Period. The directors and employees of the Promoter, its related companies, agencies, suppliers and JURA stockists (and members of all such persons' immediate families) are ineligible to participate in the Promotion. Claim forms with an address outside of Australia will be deemed invalid.
3. This Promotion cannot be accepted or used in conjunction with any other offer. It is not transferable or exchangeable by the consumer.
4. You must pay the full purchase price for the Eligible Product during the Promotion Period in order to be eligible to receive a complimentary in-home installation by the Promoter. The Promoter is not obliged to honour any claim where the consumer has paid only the deposit on a participating JURA product or have entered into a rental, lay-by (unless the lay-by was commenced and paid in full during the Offer Period), seconds or scratch and dent products.
5. Only one claim is permitted per Eligible Product purchased. Multiple claims are permitted provided that a separate entry is completed for each Eligible Product purchased. A limit of 3 claims per household applies.

The online form must be completed and original receipt scanned and uploaded. Form may also be printed and together with a copy of original receipt, mailed to JURA EOFY Offer, 7-9 Hall Street, Hawthorn East, VIC 3123. Entries must be received by last mail on 7th November 2020. Claims redeemed after this date will be deemed invalid and consumers will not receive a complimentary in-home installation. Upon validation of the claim form, consumers will be contacted via phone or email by a JURA consultant to arrange their complimentary in-home installation.
8. The promoter is not responsible for any delays in payment or errors due to factors outside its reasonable control.
9. Each complimentary in-home installation will be 30 minutes in duration and include information regarding programming, maintenance advise and general tips and tricks to ensure the user is getting the most out of their coffee machine.

The Promoter reserves the right at any time before, on and/or after the closing date of the promotion to verify the validity of claims and to disqualify any claimant who tampers with claiming process or who submits a claim that is not in accordance with these Terms and Conditions.
