

JURA Christmas Promotion 2020 Terms and Conditions

1. Information on how to claim and information on the Promotion form part of these Terms and Conditions. Participating in this Promotion is deemed acceptance of the Terms and Conditions of entry. Only registrations which are submitted and comply with these conditions of entry may take part in this promotion.
2. The offer is only open to Australian residents who purchase the participating models during the Promotion Period. The directors and employees of the Promoter, its related companies, agencies, suppliers and JURA stockists (and members of all such persons' immediate families) are ineligible to participate in the Promotion. Claim forms with an address outside of Australia will be deemed invalid.
3. This Promotion cannot be accepted or used in conjunction with any other offer. It is not transferable or exchangeable by the consumer.
4. You must pay the full purchase price for the Eligible Product during the Promotion Period in order to be eligible to receive a JURA Cappuccino Gift Pack from the Promoter.
